COVID-19 Release

In response to COVID-19, the Salmonid Restoration Federation ("SRF") will be implementing the following safety protocols for the 24th Annual Coho Confab (the "event") to be held in Leggett, California September 9-11, 2022:

- Following the latest CDC, state, and county COVID-safety guidelines;
- Providing several hand sanitizing stations around the event facilities for easy access and use;
- Implementing social-distancing measures;
- Requiring wearing of masks at all times within the event facilities when not consuming food or beverage; and
- Requiring proof of vaccinations or a negative COVID test within 24 hours

I am choosing to attend the above event in-person. I understand that in attending the event, there are risks pertaining to COVID-19, including personal injury, emotional injury, sickness and even death. I acknowledge that I am in the strongest position to properly assess my health, temperament, and other vulnerabilities with respect to the risks associated with attending the event. I understand and acknowledge that my judgement provides the sole basis for that decision to attend the event.

I hereby expressly waive and release any and all claims, now known or hereafter known in any jurisdiction throughout the world, against SRF, and its members, employees, agents, successors, assigns, volunteers, and affiliates, arising out of or attributable to participating in the event, whether arising out of the negligence of SRF or otherwise. I covenant not to make or bring any such claim against SRF, and forever release and discharge SRF from liability under such claims.

I shall defend and indemnify SRF against any and all losses, damages, liabilities, deficiencies, claims, actions, judgments, settlements, interest, awards, penalties, fines, costs, or expenses of whatever kind, including reasonable attorney fees, fees, and the costs of enforcing any right to indemnification under this Agreement and the cost of pursuing any insurance providers, incurred by indemnified party, arising out or resulting from any claim related to my participation in the event.

Additionally, I agree to abide by the rules established by SRF to attend the event, including the above-referenced safety protocols. I understand that if I, or any member of my family is showing symptoms of COVID-19, I will not attend the conference.

THIS AGREEMENT PROVIDES SRF WITH YOUR ABSOLUTE AND UNCONDITIONAL CONSENT, WAIVER, AND RELEASE OF LIABILITY. BY SIGNING, YOU ACKNOWLEDGE THAT YOU HAVE READ AND UNDERSTOOD ALL OF THE TERMS OF THIS RELEASE AND WAIVER AND THAT YOU ARE GIVING UP SUBSTANTIAL LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE SRF.
